1. The cost for the first year of membership is \$495.00 with a \$295.00 annual renewal fee.
2. Member merchants agree to allow the WVCC to advertise their businesses on the WVCC website, television, radio, and in print.
3. Member merchants must provide information in a digital format for all logos, menus, and/or banners. The WVCC and/or its representatives and/or its affiliates are not responsible for listing correctness or content.
4. All agreements submitted will be reviewed for content and, if accepted, posted on the WVCC website within three (3) business days of receipt. Management of the WVCC will not accept any listings that are deemed objectionable.
5. Member merchants wishing to make changes in their WVCC listings must submit the proposed change to the WVCC in writing within five (5) business days of the proposed change.
6. Website changes may be made whenever necessary for a nominal fee payable to the WVCC web designer.
7. If a business owner no longer wishes to participate, WVCC must be notified, in writing, 30 days prior to requested cancellation date. No refunds or exchanges will be given.
8. Management of the WVCC assumes no responsibility or liability for quality of products or services offered by participants, their employees, or their affiliates.

### **BLT Advantage Terms and Conditions:**

**A brief summary of the costs and/or terms for BLT Values Card, BLT Bargains, and BLT Community Dollars:**

#### **BLT Values Card:**

1. Participants agree to honor their offers posted on the BLT Values web site.
2. Participants agree to pay BLT Values 10% of sales generated by customers using BLT Cards.
3. A portion of all collected fees will be donated to local schools, churches, or non-profits.

#### **BLT Bargains:**

BLT Bargains sells either physical or virtual cards gift cards to customers. These cards can be generic, supplied by BLT for use with any participating merchant or gift cards supplied by a merchant for use only in their business.

1. Participants agree to honor BLT Bargains and/or their Merchant Gift Cards, virtual or physical, at full face value.
2. Physical cards, sold by BLT Bargains, can be used at full face value when shopping with participating merchants or redeemed for cash at 45% of face value.
3. A 10% fee in BLT Community Dollars is charged for sales made using virtual BLT Bargains. The remaining 90% of the virtual BLT Community Dollars may be used at full value when shopping with other participating merchants or redeemed for cash at 50% of face value.
4. If a participant wishes to redeem their BLT Community Dollars or their merchant gift cards for cash, BLT Advantage must be given notice within 24 business hours and the participant must have a minimum of \$500 worth of cards to redeem.

#### **BLT Community Dollars:**

1. BLT Community Dollars is a form of virtual currency that can be used to shop with participating merchants.
2. Working much like a bank, BLT Community Dollars records online transactions and provides statements showing information such as the sales and purchases of participating merchants.
3. Merchants earn BLT Community Dollars by making sales from the BLT Community Dollars website, selling to other BLT Community Dollars member merchants, or by selling their gift cards through BLT Bargains.
4. Participants agree to honor BLT Community Dollars at fair retail prices.
5. Physical cards, sold by BLT Community Dollars can be used at full face value when shopping with participating merchants.
6. A 10% fee in BLT Community Dollars is charged for sales made using virtual BLT Bargains.
